A list will be maintained on the NAPA website stating all bulls enrolled in the Semen Certificate Program, the date they were enrolled, and the \$ Value of their Certificates.

Changes to the Semen Certificate Fees must be made in writing to NAPA, by the owner of the bull, and date(s) of change(s) will be posted on the website.

NOTE: if a bull owner sells semen under a set Certificate fee, and later changes the Certificate fee, the semen buyer is entitled to pay the Certificate fee that was in place for the bull at the time he purchased the semen. It is strongly recommended that the bull owner and semen purchaser sign the Semen Purchase Agreement available from NAPA, at the time semen is purchased, in order to record that both parties understand their obligations and the fee(s) required for Semen Certificates.

Semen Certificates will be available on the NAPA website. **It will be the semen buyer's responsibility to print off the Certificate, sign and date it, and provide it to the bull owner – together with the appropriate Certificate fee(s).**

It will be the bull owner's responsibility to sign, date and return the Certificates to the semen buyer in a timely fashion - upon being paid the Certificate fee(s).

The semen purchaser must provide the signed Semen Certificate to the Registry Office at the time he applies for registration / recordation of any calf sired by any enrolled bull.

If you already have sold semen on your bull *without* indicating that the bull may be enrolled in a Certificate Program, and you wish to enroll him now, we strongly recommend that you contact your previous semen buyers to make arrangements with them for the registry/recordation of offspring from that semen which they may have on inventory. It is recommended that bull owners provide a signed Certificate at no cost to those semen buyers who pre-date enrollment of the bull. Simply find out how many units of semen they have in inventory, and expect to provide Certificates based on an 70-80% conception rate. If you have sold semen with instruction to the buyer that the bull *may be* enrolled in a Certificate Program, then you should contact your semen buyers to inform them that the bull is being enrolled and confirm the Certificate fee to the buyer.

Note: in the event that the enrolled bull or any semen interest in the bull is sold, it will be necessary to document the ownership of any semen on storage / pending Certificates to the NAPA Association. A bull or semen interest may be sold and the original bull owner may retain the Certificate program in whole or in part. Therefore, details MUST be provided to NAPA on who will be responsible for signing Semen Certificates.
